The City Council of the City of Clay met in regular session on Tuesday, March 28, 2017, at 6:30 p.m. at Clay City Hall. Mayor Webster presided over the meeting and City Manager Ronnie Dixon, served as recorder.

Mayor Webster called the meeting to order. Pastor of Faith Lutheran Church, Karen Boda opened in prayer and Mayor Webster led everyone in reciting the Pledge of Allegiance.

Under Mayor and Council Comments

Mayor Webster reported that Clay now has 6 deputies in place and they have increased in visibility.

Councilor Baker reported that he attended CCHS NHS induction and he was honored to attend.

Councilor Becky Johnson reported that she also attended the CCHS NHS induction and is very proud of all our students. Councilor Becky Johnson informed the Council that Linda Plummer's mother-in-law had passed away.

Councilor Bo Johnson welcomed Metro PCS to the Clay area. He then reminded everyone about the Clay United dinner on April 4, 2017 at 6:30 at the Clay Community Center.

Councilor Locke reported that he would wait until the next Council meeting to award the grants for the schools. He also attended the CCHS NHS induction ceremony and was very impressed with the students and how well they did at public speaking.

Councilor Thackerson requested that gravel be put on the cut-thru to Cosby Lake Estates from the park. He asked if there were any ongoing plans for Bryant Park. Mayor Webster replied that there were none at this time.

Under Reading of Petitions, Applications, Complaints, Appeals, Communications, etc., Mayor Webster announced that there were none.

Under the City Manager's Report, Mr. Dixon reported the account balances in the General Fund = \$750,183.59; Contractors Bond = \$147,165.80; Capital Improvement Fund = \$401,318.18; 4 & 5 Cent Gasoline Fund = \$142,952.35; 7 Cent Gasoline Fund = \$85,818.00; Building Fund = \$400,000.00; Paving Supplement Fund = \$325,000.00; Contingency Fund = \$1,100,000.00; BBT Fund = \$3,027.68; Ballpark Registration Income = \$44,922.33; and Ballpark Sports Expense = (\$48,709.21).

Mr. Dixon and Mayor Webster explained the proposal they made to the State of Alabama regarding the DYS property on Old Springville Road regarding its use.

Public Comments:

Bryan Brown of 6233 Cardinal Drive stated that he was from Taylor Memorial UMC. He stated that the church was hosting a World Vision 6k on Saturday, May 6, 2017 at Cosby Lake. This will raise money for wells and clean water in Africa. Registration will be at 8:00 am and the walk/run will begin at 9:00 am. Julius Selser of 7549 Misty Lane asked who would be responsible for the upkeep of the property at 7550 Misty Lane once the demolition was complete. Mr. Dixon stated that the property owner would be responsible for the upkeep of the property.

Councilor Bo Johnson made a motion to adjourn which was seconded by Councilor Locke and approved by a unanimous vote.
